National general requirement for textile products

According to the fourth quarter (2014) of the textile spot results released by AQSIQ, the results show 160 batches casual clothing products of 160 enterprises in 11 provinces and cities, there are 14 batches of substandard products produced by 14 enterprises.

So many products could not meet the quality requirements, what's the basis requirements for the textile products? Enterprises should pay attention to that. Currently, Chinese natio nal textile requirements are mainly composed of the GB and FZ/T, includes the "GB 18401-2010, GB 5296.4-2012, products produced by enterprises should be compliance with teh related products requirements.



GB 18401-2010 National general safety technical code for textile products

This mandatory standard required any technical index, include: formaldehyde, pH value,

AZO dyes, color fastness,

odour etc. Different requirements for A, B and C Products, infant products must comply class A, textile products with direct contact to skin comply class B at least, and textile products without direct contact to skin comply class C.

The current version is version 2010 (implemented in August 1, 2012), compared with the 2003 version, new version is more practical and guidance, some of the projects more stringent requirements. As follow,

GB5296.4-2012 Instructions for use of products of consumer interest-Textiles and apparel

This standard is mandatory, come into force in May 1,2014, and had superseded GB

5296.4-1998(enforce at 2000), differs between new and old standard as follows:

GB 18401-2010 specified the requirements for sale for the textiles sold in China market, all the textile production companies must make sure that the products they produced, sold or purchased comply with the related basic technical requirements.

GB5296.4-2012 specifies that textiles must be marked with 7 items, according to the <Product quality law>, any products sold on market must be the qualified products, though the new standard cancel the previous product quality grade and the conformity mark, sampling of quality supervision departments, will in accordance with the implementation of standard products judge, so enterprises in addition to a concern for national mandatory standards should also ensure conformity of the product with the corresponding product standards, to avoid unnecessary trouble.
