

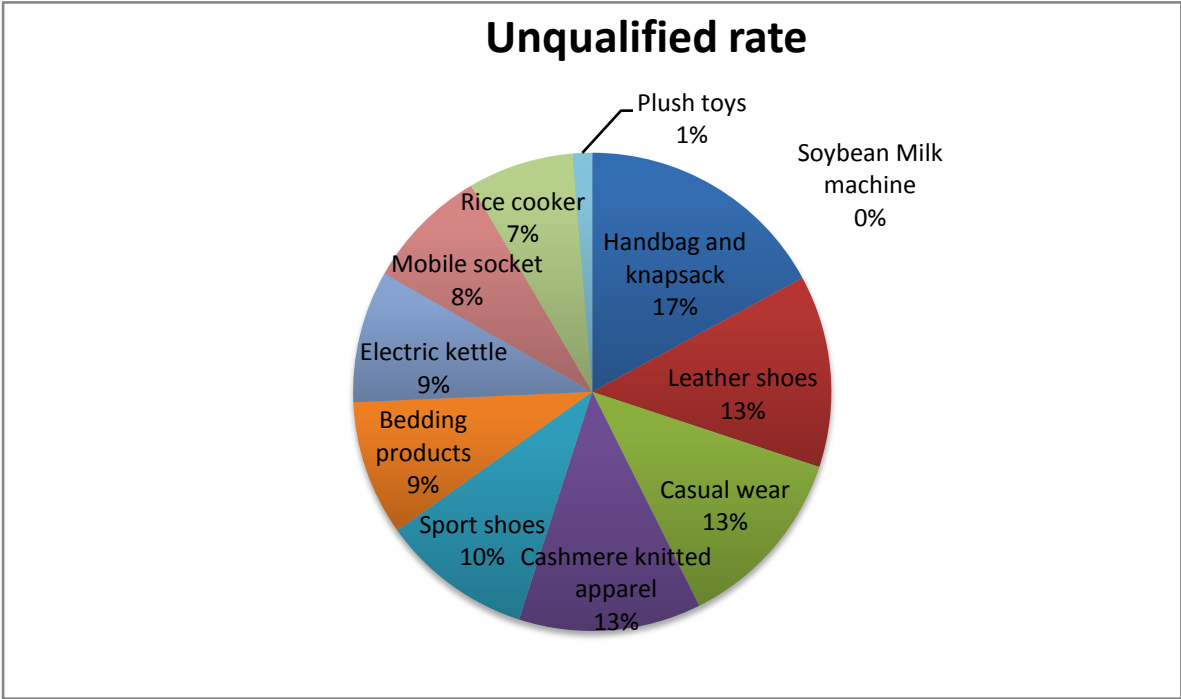


AQSIQ published the notification on the inspection result of electronic business products such as textiles

Recently, AQSIQ published the national special inspection report for online sales of toys, clothing, footwear, handbags, small home appliances and other 5 major categories of 11 kinds of products in 2015.

Abstract

Sampling concentrated to take the sample from online platform to buy and the logistics warehouse, 363 batches of e-commerce products produced by 304 companies. After inspection, 259 batches of products produced by 219 companies are qualified, qualified rate is 71.3%. Detection of 104 batches substandard products produced by 98 enterprises, substandard products detected rate of 28.7%. Product failure rate distribution is as follows:
