Turkey toys regulation amended

1 April 2017, Turkey's customs and trade ministry had published "Resmî Gazete No. 30025" amended the Year 2016 adopted Regulation on toy safety. Amendment as below:

The Regulation now provides an exemption for nickel :

1. Provided an exemption for nickel used in toys, or their components as below:
