Earlier in 17 December 2014, Consumer Product Safety Commission had voted and passed the proposed rule for the "Prohibition of Children's Toys and Child Care Articles Containing Specified Phthalates", intended to delete current restricted DNOP & DIDP, and add 4 more phthalates (DIBP, DPP, DnHP and DCHP) in the permanently banned list of CPSIA. (For details please refer to HCT previous newsletter: <u>HCT-201501-03 CPSIA phthalates control may be added to 8 items</u>)

But the proposal has been delayed, early in this year, the non-governmental organization has sued the CPSC for failing to respond to the proposal for more than two years. Currently, CPSC has agreed to finalize the final rule as soon as possible and to vote by 18 October
