## REACH ANNEX XVII newly added Methanol and NMP requirements

19 April 2018, Official Journal of the European Union published (EU)2018/588 and (EU)2018/589, amended the REACH ANNEX XVII, newly added the restricted substance 1-methyl-2-pyrrolidone and the restricted substance methanol to the list.

In REACH ANNEX XVII, the following entries are added:

## **HCT SOLUTIONS:**

(EU)2018/588 and (EU)2018/589 shall be directly applicable to all Member States, and will enter into force on the twentieth day following that of its publication in the Official Journal of the European Union. Some products shall not be placed on the market such as the wind- screen washing or defrosting fluids with a methanol concentration (by weight) equal to or greater than 0.6%. HCT remind related enterprises to pay attention to the methanol or NMP content in products to make sure of the regulation compliance.
