## Introduction to EU SCIP database

- SCIP background introduction:

SCIP is the database for information on Substances of Concern In articles as such or in complex objects (Products) established under the Waste Framework Directive (WFD).

The SCIP database ensures that the information about the presence of SVHCs is available throughout the whole life cycle of products and materials, including at the waste stage.

- The main goals of the SCIP database:

- Support the substitution of substances of concern placed on the EU market to reduce the generation of waste containing hazardous substances.
- Provide information to further improve waste treatment operations.
- Allow authorities to monitor the use of substances of concern and take appropriate actions throughout the article's life cycle (including in the waste phase).



SCIP

- SCIP notification subject

- EU suppliers of articles containing above 0.1% w/w of a substance of very high concern on the Candidate List.
- Except retailers that supply directly and exclusively to consumers
- Non-EU suppliers are not allowed to submit SCIP notifications.
- Support imports in the EU to fulfil their regulatory obligations by submitting SCIP notifications to ECHA.

- SCIP information notification method

- Prepare notification online in IUCLID Cloud
- Prepare notification Offline in IUCLID 6 (Server & Desktop)
- Prepare notification for using System-to-System submission

- SCIP information notification content

- Article identification information: including article name, article identification code, article category, whether it is

produced in the EU, etc.;

- Safe use information: including safe use instructions;
- Provide information on SVHCs candidate substances whose concentration exceeds 0.1%.
- SCIP information notification filing date
- The notification obligation of the SCIP database will take effect on January 5, 2021. Article that have been put on the market and sold on the market need to be notified before January 5, 2021 (except items that are no longer on the market)
- Articles placed on the market after January 5, 2021 must be notified .
- The SCIP notification system is scheduled to be officially launched at the end of October 2020.
- Information can be sent to the SCIP database (dossier) in one of two ways:
- Online submission through ECHA portal;
- Through the system-to-system (S2S) that from the company's own system to the ECHA submission portal to transfer dossier created in your own system.
