The latest trend analysis of REACH Annex XVII restricted substances

Article 67, paragraph 1, of the EU REACH regulation stipulates that if the restricted substances in Annex XVII contained in the substance, mixture or article do not meet the limit value requirements, these substances, mixtures or articles shall not be placed on the market. At present, ECHA (European Chemicals Agency) has initiated the evaluation of restriction proposals for a number of substances. Among the proposed restricted substances, the substances that need to be focused on in electronic appliances and peripheral products are as follows:



6	Medium chain chlorinated paraffins (MCCP)	Offers two restriction options A: MCCP is prohibited from being manufactured and placed on the market, with a limit of 0.1% in substances, mixtures or articles, and a transition period of 2 years; B: The limit is 0.1% in substances, mixtures or articles, the transition period is 2 years, there is a partial exemption for metalworking fluids, the transition period is 7 years.
